## Additional comments:

**Methyl Eugenol** - According to Cosmetic Regulation (EC) No 1223/2009 Annex III methyl eugenol is restricted to a maximum concentration in a ready to use preparation as follows

Fine fragrance – 0.01% Fragrance cream - 0.002% Eau de toilette - 0.004% Rinse-off products - 0.001%

Other leave-on products and oral products - 0.0002%

"Safrole, Isosafrole and/or Dihydrosafrole as such should not be used as fragrance ingredients.

The natural extracts containing Safrole, Isosafrole and/or Dihydrosafrole should not be used as substitutes for these ingredients. "

The level of Toluene has to be kept as low as practicable and should never exceed 100 ppm in the fragrance compound/mixture or fragrance oil. Should not be used as a fragrance ingredient.
